On Thursday, January 3, 2019, at approximately 0545 hours, I responded to a Harassing Communications call at _____, Stockbridge (Henry County) Georgia 30281. On arrival, I spoke with the complainant Timothy T. Savage _____ who advised he was being threatened by Don Russell. Don is the manager of R&B singer Robert S. Kelley "R. Kelley".

Timothy stated him and his wife are involved with the Lifetime Documentary "Surviving R. Kelly" which airs today, January 3, 2019. Their involvement with the documentary is why they are receiving threats from Don. Don texted Timothy, at approximately 0500, from phone numb _____ telling him it would be best for him and his family if the documentary does not air. Don later called Timothy while I was at the residence. Timothy placed the phone call on speak phone so I could hear the conversation. Don says several times that Timothy is providing Lifetime false information, and if he continues supporting the documentary, that they (R. Kelly / Don) would be forced to provide information disproving Timothy. Don advised Timothy that the information would ruin him, his reputation, business, and family, because it would show him a liar. I obtained a written statement from Timothy.

The case is being forwarded to CID for further investigation.
